## **NEXT STEPS:**

1. Decision: Working party agreed that a Neighbourhood Plan for Thrussington should be produced rather than alternative options as, when produced, it is binding and has statutory force. The plan should cover a period of five years and reviewed and updated regularly (as appropriate).

2. Register interest with designated local planner at Charnwood Borough Council, Hannah Hamilton-Rutter. Set meeting date – NS.

Objectives: Register interest and personnel with HHR

Obtain map to designate area of interest

(agreed it should be full Parish).

Ask about funding options

3. Ask Parish council for requirements for a constitution for sub-committee, can we use PC constitution as a basis?

Confirm Working Parties group and give names to PC.

Ask whether the NP could be discussed at AGM.

Determine terms of reference for working party members – TP (Helen Chadwick).

Determine how we identify declarations of interest and what mandatory

requirements apply to our group – TP(Helen).

Ask for space in Thrussington Life for updates to village. MT TP NS

4. Funding, consultants etc:

Peter Edwards – Send investigative mail (PR)

Investigate any suggestion from HHR (note added by MT after meeting – LRALC could be approached. LRALC is a body set up to help Parish Councils).

Possibility of asking Paul Wilcox for advice on some aspects of the plan (ex-council planning expert).

Possible fund raising events could be set up in the village, possibility that PR could approach Big Bad night organisation, LN could ask Church about a coffee morning. Council precept for 2016 has included a request for £1000 to be ring fenced for the Neighbourhood plan.

- 5. Other comments, notes and actions:
  - a. Participate at the Hoby open meeting for their NP. TP to send details but thought to be a 7pm meeting in February at the Hoby Village Hall. TP/ALL
  - b. Potential to link up with Ratcliffe Council. It was noted that a proper footpath between the two villages could be beneficial and could be added to our potential developments for Thrussington.
  - c. Obtain other NP's as documents that may help. SR for Keyworth. NH for general search. MT has one for Cottesmore. NH SR
  - d. Think about obtaining information on land ownership / businesses. SR
  - e. Potential area for playground near Back Lane (Mrs Cursham).
  - f. From Charnwood strategy document: Over 17000 houses to be built in borough between 2006 and 2028. 500 of these to be in "other settlements" of which we are one. Charnwood has 5 year plan for housing which is nearly 100% filled. It was noted that those areas without a NP may be targeted for development by businesses (presumption in favour of development). NH has relevant notes.

## **OUSTANDING ACTIONS:**

- 1. Powerpoint presentation to be an ongoing document for possible presentation to the village at the AGM.
- 2. Spokesperson for working party identified as NS. At this stage should not be MT or TP as members of Parish council. Others are welcome to any council meeting.
- 3. Venue for future meetings SR residence.
- 4. Other actions:
  - a. Contact Janet Heath HHR copy of talk on village MT.
  - b. Contact Janet Heath for copy of old local plan MT
  - c. Contact Rearsby NP party and, perhaps, Hoby. LN to ask a friend who is on the Rearsby committee (informally at first) LN.
  - d. Begin to think of local businesses to contact as well as church and school ALL.
